However, the above RAISIN varieties can be produced kosher for Passover, kitniyot-free, if the raisins are **NOT** coated with any oil at all.

Kitniyot-free raisins will be produced under full-time supervision (hashgacha t'midit) and a specific Passover (kitniyot-free) certificate will be issued for each consignment

These products are also marketed under the “Safari” and “S.A.D.” labels.

This certificate is valid until **31 DECEMBER 2022** at which stage it is subject to renewal.

Placing the Beth Din logo on products not listed above constitutes an unauthorized use of the Beth Din symbol, which is a registered trademark.
